



## MEEM ATOLL STATE HOUSE

### **All guests should abide by the house rules & regulations:**

- 1- On arrival, guests must register at the house reception desk. All guests are requested to present a valid identity card. Passport, visa or travel documents to prove their identity and to indicate the purpose or their stay when they check in at the house.
- 2- All guests should take good care of the property in the house and cooperate with the house personnel when carrying out their duties.
- 3- Guests are not allowed to accommodate any unregistered guests for the night, if she/he wishes to accommodate a visitor, the house management should be informed beforehand. Guests are kindly requested to inform the reception desk if they invite more than one person to a single room and more than two people to a double room. Visitors are also expected to abide by the house rules and regulations.
- 4- The house is not responsible for the safety of residents' personal belongings, valuable items, artistic material or work. Guests are advised to consult their insurers for coverage of such items. Small objects may be deposited in the safe.
- 5- No birds, animals or unsanitary articles may be brought in the house. No pets allowed.
- 6- Guests are requested to inform the reception desk as soon as possible in advance of any prolonged absence, as well as in the event of departure prior to the scheduled departure date.
- 7- No inflammable, explosive, corrosive, toxic, radioactive, or other dangerous articles may be brought into house. No burning of items (including candles) or Ignition of fireworks or firecrackers or use of open flames is permitted in the house. Smoking is strictly prohibited inside the room/Toilet or lobby.





- 8- It is forbidden to add or to modify electric installations or use additional electrical equipment such as electric heaters, electric stoves, cooking devices, microwave ovens, etc.
- 9- Noisemaking or playing music loudly in a way that is disturbing to other guests is forbidden in the house.
- 10- All guests should comply with the Maldives law and regulations.
- 11- The house staff has the authority to prosecute anyone who has violated the above-mentioned rules and regulations. Disorderly behavior or non-compliance with the rules and regulations may result in eviction as well as payments for any damage caused. Those who violate the Maldives law and regulations will be prosecuted accordingly.
- 12- Guests are requested pay by local currency (MVR)
- 13- Credit card, debit card, cheque payments are not acceptable, hence bank transfer/ Cash can be accepted.
- 14- Check out time is 12:00pm always.
- 15- Children under 18 must always have proper adult supervision.
- 16- Please turn off the air conditioner, all electrical appliances and lights when not is use and whenever you leave the room.
- 17- Trash must be placed in a proper receptacle or in the pickup bin inside the room, guests are asked to maintain a neat and clean-living area.
- 18- Visitors are not allowed to stay after 11:30 pm
